In consideration of your acceptance of my entry, I am being permitted to participate in **FIRST SUMMER INVITATIONAL** tournament for any purpose including but not limited to competition, observation, use of facilities, equipment or participation in any way, the undersigned, for himself or herself and any personal respective, heir, and next of kin hereby acknowledges, agrees and represents that I hereby release J Park Taekwondo and/or their respective officers, agents, representatives, referees, employees, managers, trainers, instructors, and/or any other person affiliated in any manner with **FIRST SUMMER INVITATIONAL** tournament their successors and/or assigns from all claims which may hereafter develop or occur to me on account of, or by reason of any manner, thing or condition, negligence or default whatsoever. I hereby assume and accept the full risk and danger of any injury or damage, which may occur through, condition, negligence, or default of any person or persons whatsoever. The undersigned hereby releases, waives, discharges and covenants not to sue The **FIRST SUMMER INVITATIONAL** tournament Committee, the J Park Taekwondo School, and/or their respective officers, directors, agents, representatives, referees, employees, managers, trainers, instructors, and/or any other person (hereinafter referred to as "releases") from any liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demand therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the participants or otherwise while the undersigned is in, upon or about the premises of any facilities or equipment therein or is observing or participating in The **FIRST SUMMER INVITATIONAL** tournament whether at the premises or facilities or otherwise.

The undersigned acknowledges that participation in a martial arts tournament or program is an inherently dangerous sport in which the undersigned participates at own risk.
